CWT completed acquisition of remaining 24% shares

SINGAPORE, July 7, 2008 – Carlson Wagonlit Travel (CWT), the leading travel management company, announced today that it has acquired the remaining 24 percent of shares in Indtravels Private Limited, now known as CWT India Private Limited (“CWT India”), from AFL Private Ltd., its joint venture partner and India’s leading supply chain management company.

The acquisition underlines the company’s deep commitment to India’s growing corporate travel market, where CWT India is already the market leader with 12 offices across 10 cities and more than 1,000 employees.
